Important Questions	Answers	Why This Matters:
<b>What is the overall deductible?</b>	<p>IN NETWORK \$1,000/Individual or \$2,000/Family</p> <p>OUT OF NETWORK \$2,000/Individual or \$4,000/Family</p>	<p>Generally, you must pay all of the costs from providers up to the <b>deductible</b> amount before this <b>plan</b> begins to pay. If you have other family members on the <b>plan</b>, each family member must meet their own individual deductible until the total amount of <b>deductible</b> expenses paid by all family members meets the overall family <b>deductible</b>.</p>
<b>Are there services covered before you meet your deductible?</b>	<p>Yes. <b>Preventive Care</b> and primary care services are covered before you meet your <b>deductible</b>.</p>	<p>This <b>plan</b> covers some items and services even if you haven't met the <b>deductible</b> amount. But a <b>copayment</b> or <b>coinsurance</b> may apply. For example, this plan covers certain <b>preventive services</b> without <b>cost sharing</b> and before you meet your deductible. <b>Are there services deductibles for specific services?</b>	<p>No.</p>	<p>You must pay all of the costs for these services up to the specific <b>deductible</b> amount before this plan begins to pay for these services.</p>
<b>What is the out-of-pocket limit for this plan?</b>	<p>For <b>network providers</b> \$6,600 individual / \$13,200 family.</p>	<p>The <b>out-of-pocket limit</b> is the most you could pay in a year for covered services. If you have other family members in this plan, they have to meet their own <b>out-of-pocket limits</b> until the overall family <b>out-of-pocket</b> limit has been met.</p>
<b>What is not included in the out-of-pocket limit?</b>	<p><b>Copayments</b> for certain services, <b>premiums</b>, <b>balance-billing charges</b>, and health care this <b>plan</b> doesn't cover.</p>	<p>Even though you pay these expenses, they don't count toward the <b>out-of-pocket limit</b>.</p>
<b>Will you pay less if you use a network provider?</b>	<p>Yes. Visit <a href="http://www.carevalet.com">www.carevalet.com</a> or call 1-833-BENEBAAY for a list of <b>network providers</b>.</p>	<p>This <b>plan</b> uses a provider <b>network</b>. You will pay less if you use a <b>provider</b> in the plan's <b>network</b>. You will pay the most if you use an <b>out-of-network provider</b>, and you might receive a bill from a provider for the difference between the provider's charge and what your <b>plan</b> pays (<b>balance billing</b>). Be aware, your <b>network provider</b> might use an <b>out-of-network provider</b> for some services (such as lab work). Check with your <b>provider</b> before you get services.</p>
<b>Do you need a referral to see a specialist?</b>	<p>No.</p>	<p>This <b>plan</b> does not require you to seek a referral from your <b>primary care physician</b> prior to seeing a <b>specialist</b>.</p>

**Does this plan provide Minimum Essential Coverage? Yes**

If your plan doesn't meet the Minimum Value Standards, you may be eligible for a premium tax credit to help you pay for a plan through the Marketplace.
